

Stupp Fiber SoKY Ice Rink Ticket Giveaway Official Rules

NO PURCHASE NECESSARY. A purchase will not increase your chance of winning.

Eligibility. The SoKY Ice Rink Ticket Giveaway (the “Promotion”) is open to only to legal residents of the state of Kentucky who are at least 18 years of age at the time of entry (the “Entrant”).

The Promotion is void where prohibited by law. Employees and their immediate family members (parents, children, siblings or spouse, regardless of where they live, or persons living in the same household, whether related or not) of Sponsor, any prize provider(s), Facebook, and each of their respective parents, subsidiaries and their franchisees, affiliates, advertising and promotion agencies, distributors, individual retail licensees and any others engaged in the development, production, execution or distribution of this Promotion (all of the aforementioned collectively referred to as the “Promotion Entities”), are not eligible to participate or win a prize.

Timing. Promotion begins at 5:00 p.m. Central Time (“CST”) on 11/29/2023 and ends at 5:00 p.m. CST on 12/07/2023 (the “Promotion Period”). Sponsor’s servers and clock shall serve as the official clock for the Promotion and participants’ proof of submission does not constitute proof of receipt by Sponsor.

How to Enter: During the Promotion Period, Entrants may enter Facebook, as outlined below.

Facebook: Log into or create your Facebook account, create a Facebook post with a video or picture of your best skating move or hockey goal, tag Stupp Fiber in the post, and tag a friend age 18 or older in the post. You must get your friend’s permission prior to including the friend in your Submission. If you do not have the Facebook App, you may download it through the application store on your mobile device. Creating a Facebook account is free, but is subject to Facebook’s terms and conditions (<https://facebook.com/legal/terms>.)

Each complete entry shall hereinafter be referred to as a “Submission”. Provided an Entrant’s Submission conforms to these Official Rules, upon completing a Submission, each Entrant will receive one (1) entry into the Promotion.

Additional Conditions. The Submission must be in English. Submissions must not include information about any individual under the age of 18.

Limit one entry per person. Submissions will not be returned or acknowledged. Entries are non-assignable.

No other methods of entry are acceptable. Any attempt by a participant to obtain more than the stated number of entries by using multiple/different email addresses, identities or any other methods will void that participant’s entry and that participant may be disqualified. Sponsor reserves the right to disqualify an entry with offensive content or material that it feels is inappropriate in any way. Late entries or entries sent via any method other than as stated above will not be accepted.

In the event of a dispute regarding the identity of the person who submitted an entry, the entry will be deemed submitted by the Authorized Account Holder (defined below) of the e-mail address connected with the Facebook account from which the entry was sent. "Authorized Account Holder" is defined as the natural person who is assigned to an e-mail address by the Internet access provider, online service provider, or other organization (e.g., business, educational institution, etc.) that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address.
